

The Uncertainty of Noise Composed of Separate Sound Events

Transportation noise is a main source of noise pollution. It is assumed that it consists of recognizable noise events which come from moving aircrafts, trains and boats. The noise of an isolated sound event is assessed by the sound exposure level, L_{AE} . Much legislation and many regulations and guidelines employ the A-weighted time-average sound level, $L_{Aeq,T}$, with the time interval T of one hour or longer. L_{AE} measurements enable an approximation of $L_{Aeq,T}$. The key point is the uncertainty of this approximation. It has been shown that an increase in the number of L_{AE} categories brings about a decrease in uncertainty. For illustrative purposes, L_{AE} measurements of aircrafts taking off and landing were carried out.

Keywords: noise propagation.

1. Introduction

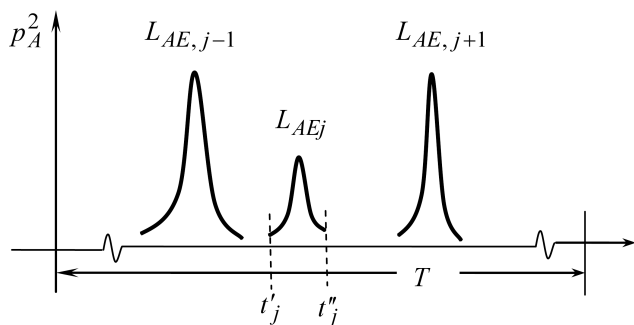


Fig. 1. Environmental noise composed of noise events: $\dots, L_{AE,j-1}, L_{AE,j}, L_{AE,j+1}, \dots$

Noise pollution due to transportation (e.g. aircraft noise) has increased over recent years (BABISCH, 2007; MURPHY, 2009; PIRRERA, 2010). To quantify noise, much legislation and many regulations and guidelines employ the A-weighted time-average sound level, $L_{Aeq,T}$, with the time interval T of one hour or longer (Survey, 2009; ANSI, 1960; ISO, 2003). Sometimes, transportation noise is composed of discrete sound events, such as aircraft operations train- and boat-pass-bys (Fig. 1). The noise of an isolated sound event is measured in terms of the sound exposure level, L_{AE} . Due to differences in noise generation and propagation the measured values of L_{AE} are not identical, so their categorization is possible. The grouping of aircraft operations into take offs and landings is the simplest example (Sec. 3).

This study shows that grouping all L_{AE} into two, three or more categories (Sec. 4) decreases the uncertainty of $L_{Aeq,T}$ approximation. For one category of sound events (Sec. 2), this uncertainty can be calculated from (see CALIGURI, 2007; KEPHALOPOULOS, 2007; MAKAREWICZ, 2008 and the literature cited therein),

$$\sigma_L = \frac{10}{\ln 10} \frac{\sigma_\varepsilon}{\sqrt{q} \cdot \langle \varepsilon \rangle}. \quad (1)$$

Here q expresses the number of L_{AE} measurements. The empirical mean $\langle \varepsilon \rangle$, and the variance, σ_ε^2 , of the event sound exposure can be obtained from,

$$\langle \varepsilon \rangle = \frac{1}{q} \sum_{j=1}^q 10^{0.1 L_{AEj}}, \quad \langle \varepsilon^2 \rangle = \frac{1}{q} \sum_{j=1}^q 10^{0.2 L_{AEj}}, \quad (2)$$

$$\sigma_\varepsilon^2 = \langle \varepsilon^2 \rangle - \langle \varepsilon \rangle^2.$$

In Secs. 3 and 4 the generalization of Eq. (1), for two- and more categories, is derived. The new uncertainty is less than σ_L (Eq. (1)). This is an important result, because any decrease in the uncertainty enhances the reliability of $L_{Aeq,T}$ approximation. For illustrative purposes, aircraft noise measurements were carried out. Nevertheless, the results of this study can be used for any type of noise which is composed of recognizable noise events (Fig. 1).

2. One category of noise events

Taking into account Q noise events within the time interval T , the combination of definitions of $L_{Aeq,T}$ and L_{AE} yields the exact value of the A-weighted time-average sound level (ANSI, 1960; ISO, 2003; MAKAREWICZ, 2008)

$$L_{Aeq,T} = 10 \log \left\{ \frac{t_o}{T} \sum_{j=1}^Q 10^{0.1L_{AE,j}} \right\}, \quad t_o = 1 \text{ s}, \quad (3)$$

where

$$L_{AEj} = 10 \log \{ \varepsilon_j \}, \quad (4)$$

is the j -th sound exposure level. With the time pattern of the A-weighted squared sound pressure for the j -th event, $p_{Aj}^2(t)$ (Fig. 1), the integral

$$\varepsilon_j = \int_{t'_j}^{t''_j} \frac{p_{Aj}^2}{p_o^2} \frac{dt}{t_o}, \quad p_o = 20 \text{ } \mu\text{Pa}, \quad (5)$$

brings about the event sound exposure. The exact mean of the event sound exposure is,

$$\bar{\varepsilon} = \frac{1}{Q} \sum_{j=1}^Q 10^{0.1L_{AEj}}, \quad (6)$$

where Q denotes the exact number of noise events within the time interval T . Consequently, the exact value of A-weighted time-average sound level (Eq. (3)) can be rewritten as,

$$L_{Aeq,T} = 10 \log \left\{ \frac{Qt_o}{T} \cdot \bar{\varepsilon} \right\}, \quad (7)$$

Suppose that $q < Q$ measurements of the sound exposure level,

$$L_{AE1}, \dots, L_{AEj}, \dots, L_{AEq}, \quad (8)$$

is representative, i.e. encompasses all possible conditions of sound emission and propagation. Thus the empirical mean of the event sound exposure (Eq. (6)),

$$\langle \varepsilon \rangle = \frac{1}{q} \sum_{j=1}^q 10^{0.1L_{AEj}}, \quad (9)$$

yields the empirical and representative value of the A-weighted time-average sound level (Eq. (7)),

$$\hat{L}_{Aeq,T} = 10 \log \left\{ \frac{Qt_o}{T} \langle \varepsilon \rangle \right\}. \quad (10)$$

Note that the variations in noise generation and propagation could lead to different samples of L_{AE} (Eq. (8)). For such virtual samples one gets virtual

means (Eq. (9)), $\langle \varepsilon \rangle_1, \dots, \langle \varepsilon \rangle_i, \dots, \langle \varepsilon \rangle_n$, and then virtual A-weighted time-average sound levels (Eq. (10)),

$$L_{Aeq,T}^{(1)}, \dots, L_{Aeq,T}^{(i)}, \dots, L_{Aeq,T}^{(n)}, \quad (11)$$

which are calculated from,

$$L_{Aeq,T}^{(i)} = 10 \log \left\{ \frac{Qt_o}{T} \langle \varepsilon \rangle_i \right\}, \quad i = 1, \dots, n. \quad (12)$$

Note that the number of noise events, Q , within the time interval T , remains constant. Now, introducing the identity, $\langle \varepsilon \rangle_i = \langle \varepsilon \rangle + \langle \varepsilon \rangle_i - \langle \varepsilon \rangle$, with the empirical mean $\langle \varepsilon \rangle$ (Eq. (9)), and applying approximation, $\log(1+x) \approx x/\ln(10)$, we arrive at (Eqs. (10), (12)),

$$L_{Aeq,T}^{(i)} \approx \hat{L}_{Aeq,T} + \frac{10}{\ln(10)} \frac{\langle \varepsilon \rangle_i - \langle \varepsilon \rangle}{\langle \varepsilon \rangle}. \quad (13)$$

Consequently, Eqs. (11) and (13) imply that the mean of the virtual A-weighted time-average sound levels, $L_{Aeq,T}^{(i)}$, comes near to the empirical A-weighted time-average sound level,

$$\frac{1}{n} \sum_{i=1}^n L_{Aeq,T}^{(i)} \approx \hat{L}_{Aeq,T}. \quad (14)$$

On the other hand, $\hat{L}_{Aeq,T}$ (Eq. (10)) is representative for all possible conditions and approximates the exact A-weighted time-average sound level (Eq. (3)),

$$L_{Aeq,T} \approx \hat{L}_{Aeq,T}. \quad (15)$$

The uncertainty of the above approximation estimates the standard deviation, σ_L , defined by (CREMER, 1999),

$$\sigma_L^2 = \frac{1}{n} \sum_{i=1}^n \left[L_{Aeq,T}^{(i)} - \hat{L}_{Aeq,T} \right]^2 \quad (16)$$

and the combination of Eqs. (2), (4), (13) and (16) leads to the well known formula (1).

Example 1. L_{AE} measurements of aircraft operations were performed in the vicinity of a one runway airport. To the more instructive we disregard differences between aircraft types, flight profiles, meteorological conditions, etc., and assume one category of noise events. The sample of the measured sound exposure levels,

$$L_{AEj} = 80.3, 65.2, 75.1, 72.1, 78.8, 78.7, \\ 86.4, 68.1, 88.2, 69.1, 77.9, 73.2, \\ 84.1, 78.6, 83.6, 69.5 \text{ dB},$$

is characterized by (Eq. (2)): $\langle \varepsilon \rangle \approx 12.9 \cdot 10^7$ and $\sigma_\varepsilon^2 \approx 31.9 \cdot 10^{15}$. For the number of measurements $q = 16$, formula (1) yields the uncertainty, $\sigma_L = 1.5 \text{ dB}$, of the A-weighted time-average sound level approximation (15).

3. Two categories of noise events

This section shows that the splitting of the measurement sample of q elements (Eq. (8)) into two subsamples

$$L_{AE1}^{(1)}, \dots, L_{AEj}^{(1)}, \dots, L_{AE,q1}^{(1)}, \quad (17)$$

and $L_{AE1}^{(2)}, \dots, L_{AEj}^{(2)}, \dots, L_{AE,q2}^{(2)},$

with $q_1 + q_2 = q$, decreases standard deviation, $\check{\sigma}_L < \sigma_L$. In order to find the new value of $\check{\sigma}_L$, we employ two categories of noise events. For the actual number of noise events, $Q = Q_1 + Q_2$, the exact A-weighted time-average level takes the form (Eqs. (3), (7)),

$$L_{Aeq,T} = 10 \log \left\{ \frac{t_o}{T} [Q_1 \cdot \bar{\varepsilon}_1 + Q_2 \cdot \bar{\varepsilon}_2] \right\}, \quad (18)$$

where the exact means of the event sound exposures are,

$$\bar{\varepsilon}_1 = \frac{1}{Q_1} \sum_{j=1}^{Q_1} \varepsilon_{1j}, \quad \bar{\varepsilon}_2 = \frac{1}{Q_2} \sum_{j=1}^{Q_2} \varepsilon_{2j}. \quad (19)$$

To determine estimations, $\langle \varepsilon_1 \rangle \approx \bar{\varepsilon}_1$, and $\langle \varepsilon_2 \rangle \approx \bar{\varepsilon}_2$, the measurements of $L_{AE}^{(1)}$ and $L_{AE}^{(2)}$ for both categories (Eq. (17)), have to be performed. The empirical means, $\langle \varepsilon_1 \rangle$; $\langle \varepsilon_2 \rangle$, second moments, $\langle \varepsilon_1^2 \rangle$; $\langle \varepsilon_2^2 \rangle$, and variances, $\sigma_{\varepsilon_1}^2$; $\sigma_{\varepsilon_2}^2$, are obtained from Eq. (2), with q replaced by q_1 and q_2 , respectively.

Example 2. In the vicinity of the one runway airport (see Example 1), L_{AE} measurements of noise produced during take off and landing were carried out:

$$L_{AEj}^{(1)} = 80.3, \quad 75.1, \quad 78.8, \quad 86.4, \quad 88.2, \\ 77.9, \quad 84.1, \quad 83.6 \text{ dB},$$

$$L_{AEj}^{(2)} = 65.2, \quad 72.1, \quad 78.7, \quad 68.1, \quad 69.1, \\ 73.2, \quad 78.6, \quad 69.5 \text{ dB}.$$

With $q_1 = q_2 = 8$ the characteristics of ε_1 and ε_2 , are as follows (Eq. (2)):

$$\langle \varepsilon_1 \rangle \approx 23.3 \cdot 10^7; \quad \sigma_{\varepsilon_1}^2 \approx 41.9 \cdot 10^{15}, \\ \text{and} \quad \langle \varepsilon_2 \rangle \approx 2.63 \cdot 10^7; \quad \sigma_{\varepsilon_2}^2 \approx 76.3 \cdot 10^{13}.$$

The approximation of the exact A-weighted time average sound level for two categories of sound events is, $L_{Aeq,T} \approx \check{L}_{Aeq,T}$ (compare with Eq. (15)), where

$$\check{L}_{Aeq,T} = 10 \log \left\{ \frac{t_o}{T} [Q_1 \cdot \langle \varepsilon_1 \rangle + Q_2 \cdot \langle \varepsilon_2 \rangle] \right\}. \quad (20)$$

Here the empirical means, $\langle \varepsilon_1 \rangle$ and $\langle \varepsilon_2 \rangle$, come from measurements of $L_{AE}^{(1)}$ and $L_{AE}^{(2)}$, respectively

(Eq. (17)). However, variations in noise generation and propagation could lead to different means,

$$\langle \varepsilon_1 \rangle_1, \dots, \langle \varepsilon_1 \rangle_i, \dots, \langle \varepsilon_1 \rangle_n \quad (21)$$

and $\langle \varepsilon_2 \rangle_1, \dots, \langle \varepsilon_2 \rangle_i, \dots, \langle \varepsilon_2 \rangle_n$

and different values of the virtual A-weighted time average sound level,

$$\check{L}_{Aeq,T}^{(i)} = 10 \log \left\{ \frac{t_o}{T} [Q_1 \cdot \langle \varepsilon_1 \rangle_i + Q_2 \cdot \langle \varepsilon_2 \rangle_i] \right\}, \quad (22)$$

$$i = 1, \dots, n.$$

As in Sec. 2, now we apply the empirical means $\langle \varepsilon_1 \rangle$; $\langle \varepsilon_2 \rangle$ (Eq. (2), Example 2), and write identities for the virtual means of the first and the second category of noise events,

$$\langle \varepsilon_1 \rangle_i = \langle \varepsilon_1 \rangle + \langle \varepsilon_1 \rangle_i - \langle \varepsilon_1 \rangle, \quad (23)$$

$$\langle \varepsilon_2 \rangle_i = \langle \varepsilon_2 \rangle + \langle \varepsilon_2 \rangle_i - \langle \varepsilon_2 \rangle.$$

Finally, Eqs. (22), (23) and the approximation $\log(1+x) \approx x/\ln(10)$ result in the i -th virtual A-weighted time average sound level,

$$L_{Aeq,T}^{(i)} \approx \check{L}_{Aeq,T} + \frac{10}{\ln 10} \cdot \frac{Q_1 [\langle \varepsilon_1 \rangle_i - \langle \varepsilon_1 \rangle] + Q_2 [\langle \varepsilon_2 \rangle_i - \langle \varepsilon_2 \rangle]}{Q_1 \cdot \langle \varepsilon_1 \rangle + Q_2 \cdot \langle \varepsilon_2 \rangle}. \quad (24)$$

The level $\check{L}_{Aeq,T}$ (Eq. (20)) expresses the mean of the above levels, $L_{Aeq,T}^{(i)}$ (Eqs. (14), (24)), and their variance can be found from (compare with Eq. (16)),

$$\check{\sigma}_L^2 = \frac{1}{n} \sum_{i=1}^n [L_{Aeq,T}^{(i)} - \check{L}_{Aeq,T}]^2. \quad (25)$$

With some calculations the above Eqs. (24) and (25) combine into the new variance for two categories of noise events,

$$\check{\sigma}_L = \frac{10}{\ln 10} \cdot \frac{\sqrt{Q_1^2 \frac{\sigma_{\varepsilon_1}^2}{q_1} + Q_2^2 \frac{\sigma_{\varepsilon_2}^2}{q_2}}}{Q_1 \langle \varepsilon_1 \rangle + Q_2 \langle \varepsilon_2 \rangle}. \quad (26)$$

For the same number of noise events in both categories, $Q_1 = Q_2 = Q/2$, and the same number of L_{AE} measurements, $q_1 = q_2 = q/2$, the above relationship translates into,

$$\check{\sigma}_L = \frac{10}{\ln 10} \frac{\sqrt{2(\sigma_{\varepsilon_1}^2 + \sigma_{\varepsilon_2}^2)}}{\sqrt{q} [\langle \varepsilon_1 \rangle + \langle \varepsilon_2 \rangle]}. \quad (27)$$

If the differences between two categories of noise events disappear (e.g. L_{AE} measurements of train noise far away from the double-track railway), then $\sigma_{\varepsilon_1} \approx \sigma_{\varepsilon_2}$ and $\langle \varepsilon_1 \rangle \approx \langle \varepsilon_2 \rangle$. Ultimately, Eqs. (1) and (27) yield identical standard deviations, $\sigma_L = \check{\sigma}_L$, as expected.

Example 3. In Example 2 we made use of $q_1 = q/2 = 8$ values of $L_{AE}^{(1)}$ (take off) and $q_2 = q/2 = 8$ values of $L_{AE}^{(2)}$ (landing). Substitution of $q = 16$, $\langle \varepsilon_1 \rangle \approx 23.3 \cdot 10^7$; $\sigma_{\varepsilon_1}^2 \approx 41.9 \cdot 10^{15}$, and $\langle \varepsilon_2 \rangle \approx 2.63 \cdot 10^7$; $\sigma_{\varepsilon_2}^2 \approx 76.3 \cdot 10^{13}$ into Eq. (27) gives the new standard deviation, $\check{\sigma}_L = 1.2$ dB, for two categories of sound events. In Example 2 the classic standard deviation, $\sigma_L = 1.5$ dB, for a single category of noise event was calculated.

Example 4. The aircraft noise measurements described in Example 2 were repeated 5 more times. The number of measurements were: $q_1 = q/2 = 5, 7, 5, 6, 6$ (take off operations) and $q_2 = q/2 = 5, 7, 5, 6, 6$ (landing operations). The corresponding values of $\langle \varepsilon_1 \rangle$; $\sigma_{\varepsilon_1}^2$ and $\langle \varepsilon_2 \rangle$; $\sigma_{\varepsilon_2}^2$ are displayed in the first row of Table 1. The first and the second rows of Table 2 contain σ_L (classic standard deviation for one category sound events – Eq. (1)) and $\check{\sigma}_L$ (the new standard deviation for two categories of sound events, Eq. (27)). Note that in each case, $\check{\sigma}_L < \sigma_L$ (Table 2).

4. Many categories of noise events

From the measured sound exposure levels of noise events which pertain to the i -th category

$$L_{AE1}^{(i)}, \dots, L_{AEj}^{(k)}, \dots, \quad (28)$$

one gets the empirical mean, second moment, and variance of the event sound exposures (Eq. (2)),

$$\begin{aligned} \langle \varepsilon_k \rangle &= \frac{1}{q_k} \sum_{j=1}^{q_i} 10^{0.1L_{AEj}^{(k)}}, \\ \langle \varepsilon_k^2 \rangle &= \frac{1}{q_k} \sum_{j=1}^{q_i} 10^{0.2L_{AEj}^{(k)}}, \\ \sigma_{\varepsilon_k}^2 &= \langle \varepsilon_k^2 \rangle - \langle \varepsilon_k \rangle^2. \end{aligned} \quad (29)$$

The exact A-weighted time average sound level, $L_{Aeq,T}$ (Eq. (3)), is approximated by the empirical A-weighted time average sound level,

$$L_{Aeq,T}^* = 10 \log \left\{ \frac{t_o}{T} [Q_1 \langle \varepsilon_1 \rangle + \dots + Q_k \langle \varepsilon_k \rangle + \dots] \right\}, \quad (30)$$

where Q_k expresses the exact number of noise events of the i -th category within the time interval T . The uncertainty of the approximation, $L_{Aeq,T} \approx L_{Aeq,T}^*$ (Eqs. (3), (30)), can be obtained from the generalization of Eq. (26),

$$\sigma_L^* = \frac{10}{\ln 10} \cdot \frac{\sqrt{Q_1^2 \frac{\sigma_{\varepsilon_1}^2}{q_1} + \dots + Q_k^2 \frac{\sigma_{\varepsilon_k}^2}{q_k} + \dots}}{Q_1 \langle \varepsilon_1 \rangle + \dots + Q_k \langle \varepsilon_k \rangle + \dots}. \quad (31)$$

If all noise events belong to a single category, $Q_1 \rightarrow Q = Q_1 + \dots + Q_k + \dots$, $q_1 \rightarrow q = q_1 + \dots + q_k + \dots$, and $Q_2 = 0, \dots, Q_k = 0$, then Eq. (30) and (31) describe the case of one category of sound events, which is quantified by Eqs. (1), (2) and (7), (10).

5. Conclusions

Equation (31) is the key result of this study. Without categorization of noise events, the *a priori* knowledge of the number of noise events Q (within the time interval T), and q measurements of the sound exposure level, L_{AE} (Eq. (8)), enables the approximation of the A-weighted time-average sound level as follows (Eqs. (2), (3), (10)):

$$L_{Aeq,T} \approx 10 \log \left\{ \frac{Qt_o}{T} \langle \varepsilon \rangle \right\}. \quad (32)$$

The well-known relationship given by Eq. (1) defines its uncertainty, σ_L . A few noise event categories, with q_1 measurements of $L_{AE}^{(1)}$, q_2 measurements of $L_{AE}^{(2)}$, \dots , etc., leads to the approximation (Eqs. (2), (3), (30)):

$$L_{Aeq,T} \approx 10 \log \left\{ \frac{t_o}{T} [Q_1 \langle \varepsilon_1 \rangle + Q_2 \langle \varepsilon_2 \rangle + \dots] \right\}, \quad (33)$$

with the uncertainty σ_L^* (Eq. (31)). Here the actual number of noise events – Q , and the number of L_{AE} measurements – q meet the conditions: $Q_1 + Q_2 + \dots = Q$ and $q_1 + q_2 + \dots = q$. The approximation (33) is more reliable than the approximation (31) due to inequality, $\sigma_L^* < \sigma_L$ (Eqs. (1), (31)). The presented above results are applicable, when noise events are clearly recognizable.

Appendix: Two categories versus one category

To clarify the difference between uncertainties for one sound event category and two sound events categories (Eqs. (1), (26)), first we apply the classic formula (1) for the sample of event sound exposures,

$\varepsilon_1, \dots, \varepsilon_q$. Then, calculating $\langle \varepsilon \rangle$, $\langle \varepsilon^2 \rangle$ and σ_ε^2 we take into account that this sample consists of two sub-samples: $q/2$ elements belong to the first category and the remaining $q/2$ elements to the second category of noise events. Accordingly, we get the mean and the second moment of ε :

$$\begin{aligned} \langle \varepsilon \rangle &= \frac{1}{q} \sum_{j=1}^q \varepsilon_j = \frac{1}{q} \left[\sum_{j=1}^{q/2} \varepsilon_{1j} + \sum_{j=1}^{q/2} \varepsilon_{2j} \right] \\ &= \frac{1}{2} [\langle \varepsilon_1 \rangle + \langle \varepsilon_2 \rangle], \end{aligned} \quad (34)$$

$$\begin{aligned} \langle \varepsilon^2 \rangle &= \frac{1}{q} \sum_{j=1}^q \varepsilon_j^2 = \frac{1}{q} \left[\sum_{j=1}^{q/2} \varepsilon_{1j}^2 + \sum_{j=1}^{q/2} \varepsilon_{2j}^2 \right] \\ &= \frac{1}{2} [\langle \varepsilon_1^2 \rangle + \langle \varepsilon_2^2 \rangle]. \end{aligned} \quad (35)$$

Then variance, $\sigma_\varepsilon^2 = \langle \varepsilon^2 \rangle - \langle \varepsilon \rangle^2$, takes the form,

$$\sigma_\varepsilon^2 = \frac{1}{2} [\sigma_{\varepsilon_1}^2 + \sigma_{\varepsilon_2}^2] + \frac{1}{4} [\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2 \quad (36)$$

and combination with classic equation (1) brings about the uncertainty of $L_{Aeq,T}$ approximation,

$$\begin{aligned} \sigma_L^2 &= \left(\frac{10}{\ln 10} \right)^2 \frac{1}{q} \left\{ 2 \cdot \frac{\sigma_{\varepsilon_1}^2 + \sigma_{\varepsilon_2}^2}{[\langle \varepsilon_1 \rangle + \langle \varepsilon_2 \rangle]^2} \right. \\ &\quad \left. + \left[\frac{\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle}{\langle \varepsilon_1 \rangle + \langle \varepsilon_2 \rangle} \right]^2 \right\}. \end{aligned} \quad (37)$$

Note that σ_L is expressed in terms of σ_{ε_1} ; σ_{ε_2} ; $\langle \varepsilon_1 \rangle$; $\langle \varepsilon_2 \rangle$, though the summation in Eqs. (35) and (36) runs over q elements, as it would be only one category of noise events. On the other hand, the variance $\check{\sigma}_L$, for two noise event categories and the same number of events and measurements ($Q_1 = Q_2 = Q/2$, $q_1 = q_2 = q/2$), is given by Eq. (28). Mindful of Eqs. (37) and (28) one arrives at the ratio of the classic and new variances,

$$\frac{\sigma_L^2}{\check{\sigma}_L^2} = 1 + \frac{1}{2} \frac{[\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2}{\sigma_{\varepsilon_1}^2 + \sigma_{\varepsilon_2}^2}. \quad (38)$$

To grasp the meaning of this relation, suppose ε_1 and ε_2 are distributed with large variances, $\sigma_{\varepsilon_1}^2$; $\sigma_{\varepsilon_2}^2$, and empirical means close to each other, $\langle \varepsilon_1 \rangle \rightarrow \langle \varepsilon_2 \rangle$ (Fig. 2),

$$[\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2 \ll 2 \cdot [\sigma_{\varepsilon_1}^2 + \sigma_{\varepsilon_2}^2]. \quad (39)$$

Under such conditions, Eq. (38) implies that splitting sound events into two categories does not significantly decrease the uncertainty of $L_{Aeq,T}$ approximation: $\check{\sigma}_L \approx \sigma_L$. Conversely, if the categories are clearly

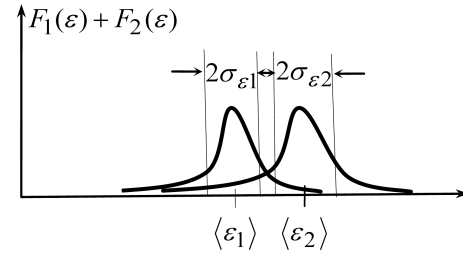

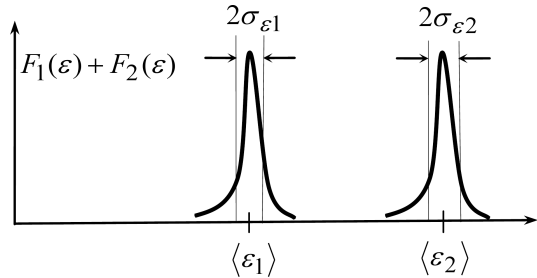


Fig. 3. Probability density function of the event sound exposure, $F_1(\varepsilon) + F_2(\varepsilon)$, for small variances, $\sigma_{\varepsilon_1}^2$; $\sigma_{\varepsilon_2}^2$, and empirical means clearly separated, $\langle \varepsilon_1 \rangle < \langle \varepsilon_2 \rangle$ (Eq. (40)).

Fig. 2. Probability density function of the event sound exposure, $F_1(\varepsilon) + F_2(\varepsilon)$, for large variances, $\sigma_{\varepsilon_1}^2$; $\sigma_{\varepsilon_2}^2$, and empirical means close to each other, $\langle \varepsilon_1 \rangle \approx \langle \varepsilon_2 \rangle$ (Eq. (39)).

separated, $\langle \varepsilon_2 \rangle > \langle \varepsilon_1 \rangle$ or $\langle \varepsilon_2 \rangle < \langle \varepsilon_1 \rangle$, and their variances $\sigma_{\varepsilon_1}^2$ and $\sigma_{\varepsilon_2}^2$ are small (Fig. 3):

$$[\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2 > 2 \cdot [\sigma_{\varepsilon_1}^2 + \sigma_{\varepsilon_2}^2], \quad (40)$$

then splitting noise events into two categories decreases the uncertainty of $L_{Aeq,T}$ approximation, $\check{\sigma}_L < \sigma_L$.

Now we reject the assumptions of there being the same number of sound events within the time interval T , $Q_1 = Q_2 = Q/2$, and the same number of measurements, $q_1 = q_2 = q/2$. So the ratios

$$p = \frac{Q_1}{Q} = \frac{q_1}{q}, \quad 1 - p = \frac{Q_2}{Q} = \frac{q_2}{q}, \quad (41)$$

express the probabilities that a sound event belongs to the first and the second category, respectively. Here $Q = Q_1 + Q_2$ equals the total number of noise events and $q = q_1 + q_2$ denotes the total number of L_{AE} measurements. Accordingly, for two categories the uncertainty of $L_{Aeq,T} \approx \check{L}_{Aeq,T}$ (Eqs. (3), (20)) estimation can be found from (Eq. (26)),

$$\check{\sigma}_L^2 = \left(\frac{10}{\ln 10} \right)^2 \frac{1}{q} \frac{p \cdot \sigma_{\varepsilon_1}^2 + (1 - p) \cdot \sigma_{\varepsilon_2}^2}{[p \cdot \langle \varepsilon_1 \rangle + (1 - p) \cdot \langle \varepsilon_2 \rangle]^2}. \quad (42)$$

Note that identical probabilities, $p = 1/2$ and $1 - p = 1/2$ (e.g. the same numbers of take offs and landings) modify the above expression to the form given by Eq. (27).

In order to prove that sound event grouping decreases uncertainty, $\sigma_L / \check{\sigma}_L > 1$, for any probability,

$0 < p < 1$, we have to generalize Eq. (36). The empirical mean and the second moment of the event sound exposure are (Eqs. (2), (4), (41)),

$$\begin{aligned} \langle \varepsilon \rangle &= p \cdot \langle \varepsilon_1 \rangle + (1 - p) \cdot \langle \varepsilon_2 \rangle, \\ \langle \varepsilon^2 \rangle &= p \cdot \langle \varepsilon_1^2 \rangle + (1 - p) \cdot \langle \varepsilon_2^2 \rangle \end{aligned} \quad (43)$$

and its variance becomes (Eqs. (2), (43)),

$$\sigma_\varepsilon^2 = p \cdot \sigma_{\varepsilon_1}^2 + (1 - p) \cdot \sigma_{\varepsilon_2}^2 + p(1 - p) \cdot [\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2. \quad (44)$$

Inserting the above $\langle \varepsilon \rangle$ and σ_ε^2 into formula (1) one arrives at the generalization of Eq. (36),

$$\begin{aligned} \sigma_L^2 &= \left(\frac{10}{\ln 10} \right)^2 \frac{1}{q} [p \cdot \langle \varepsilon_1 \rangle + (1 - p) \cdot \langle \varepsilon_2 \rangle \\ &+ p(1 - p) [\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2] / [p \cdot \langle \varepsilon_1 \rangle \\ &+ (1 - p) \cdot \langle \varepsilon_2 \rangle]^2. \end{aligned} \quad (45)$$

Ultimately, combination of formulae (42) and (45) yields the ratio,

$$\frac{\sigma_L^2}{\check{\sigma}_L^2} = 1 + f(p). \quad (46)$$

The function of the probability, $0 < p < 1$ (Eq. (43)),

$$f(p) = \frac{p(1 - p) \cdot [\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle]^2}{p \cdot \sigma_{\varepsilon_1}^2 + (1 - p) \cdot \sigma_{\varepsilon_2}^2}, \quad (47)$$

has a maximum at

$$p = \frac{\sigma_{\varepsilon_2}}{\sigma_{\varepsilon_1} + \sigma_{\varepsilon_2}}. \quad (48)$$

The corresponding maximum of $\sigma_L^2 / \check{\sigma}_L^2$ equals (Eqs. (46), (47)),

$$\max \left\{ \frac{\sigma_L^2}{\check{\sigma}_L^2} \right\} = 1 + \left[\frac{\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle}{\sigma_{\varepsilon_1} + \sigma_{\varepsilon_2}} \right]^2. \quad (49)$$

Consequently, for two categories of noise events the minimal uncertainty equals,

$$\hat{\sigma}_L = \frac{\sigma_L}{\sqrt{1 + \left[\frac{\langle \varepsilon_1 \rangle - \langle \varepsilon_2 \rangle}{\sigma_{\varepsilon_1} + \sigma_{\varepsilon_2}} \right]^2}}. \quad (50)$$

Here σ_L (Eq. (1)) represents the uncertainty of estimation, $L_{Aeq,T} \approx \hat{L}_{Aeq,T}$ (Eqs. (3), (10)), for noise events belonging to a single category.
